Official Information Act 1982 request

Thank you for your Official Information Act 1982 (OIA) request of 9 November 2017 regarding the number of without notice applications in the Family Court that have been granted and dismissed respectively, broken down by gender for the last 5 years. On 22 November 2017, your request was clarified for the same data filed for applications under the Care of Children Act 2004.

The Ministry holds raw data about without notice applications, but analysis would be required to produce the breakdown you have requested. The OIA does not require a department to create information or put it in another form. I am therefore declining your request under s18(g) of the OIA on the grounds that the Ministry does not hold the information and I have no reason to believe it is held by or more closely connected with the functions of any other department or Minister.

I can, however, provide the following information on without notice applications:

- Table 1 shows the number of substantive applications filed without notice in the Family Court by financial year, 2012/13 to 2016/17
- Table 2 shows the number of granted substantive applications filed without notice in the Family Court by financial year, 2012/13 to 2016/17
- Table 3 shows the number of dismissed substantive applications filed without notice in the Family Court by financial year, 2012/13 to 2016/17

Note that applications may also be withdrawn/discontinued by the applicant or may lapse if the respondent cannot be located. This means that the numbers in Tables 2 and 3 will not add up to those in Table 1.

I can also provide a gender breakdown for all substantive applications filed in the Family Court, which you may find useful. Refer to table 4.
