Re: Request for information relating to the Island Bay Cycleway.

Thank you for your email to the Council received via the FYI website on 17 November 2017 in which you requested information relating to the Island Bay Cycle Way Project. Your request was forwarded to the Complaints and Information Assurance Team to provide a response.

Thank you also for your patience whilst the information has been collated.

As you asked a number of questions I will address these in the order of your email.

1) "Original project plan (with design) and budget. Please include the success criteria for the project, and its objectives"

There was no project plan pre-se. The project was part of the Long Term Plan Programme.

3) "Evaluation of the project against the original success criteria and objectives at the time of the implementation"

I can advise that no criteria were set and as such this information is not held by the Council.

4) "Cost of subsequent design changes which have been completed and cost of their implementation, including budget set for these at the outset and any budget extensions granted"

There have been no further changes to that include in the implementation cost.

5) "Budget (including contingency and cost estimates produced, contractor details not required, just the amounts) for further changes now planned timeframe for implementation"

There has been no budget set for any proposed changes. Committee were advised that the compromise option had an estimate of \$4.1M for the cycleway changes.

Concept planning is underway including discussion with service authorities, and once completed we expect to have a better understanding of what other works are planned for the Parade and the expected duration of the rebuild. We do not expect to be in a position to estimate start date and construction duration until the end of February 2018.
