NON-CREDIT COURSES

Any person with a degree or diploma of any university or with a professional qualification acquired as a student of any university who wishes to attend lectures (other than courses organised by the Department of University Extension) otherwise than for the purpose of preparing or qualifying for any university examination or professional qualification may do so at a reduced fee. Such a person shall not be charged tuition fees where they do not exceed \$20 in total. If the total fees exceed \$20, he shall not be charged for the first \$20. If the net fees do not exceed \$30, he shall be exempt from the Students' Association fee. Students enrolling under this provision shall not be entitled to attend practical classes or be granted terms. Students withdrawing from non-credit courses after 31 March will not be entitled to any refund of fees.

Where a candidate for a Master's degree, or Bachelor with Honours degree, with the approval of the Head of the Department, concurrently takes a supplementary course, the additional tuition shall be covered by the composite fee payable for the course.

TRANSFERS TO EXTRAMURAL STATUS

A student who transfers from internal to extramural enrolment not later than the 31st day of March in any year and who is entitled to a refund of all tuition fees paid in respect of his enrolment as an internal student shall pay the full extramural enrolment fee of \$5 per course. A student who transfers after the 31st day of March in any year and who is not entitled to a full refund shall not be charged the extramural enrolment fee.

LAW NOTES

Every LL.B. student on his initial enrolment shall pay eight dollars for notes to be issued throughout the course. Students transferring from other universities after completing part of the course shall pay such proportion of that amount as the Registrar shall determine. Refunds will be made as follows:
