Dear James Burke

I refer to your Official Information Act 1982 (the Act) request of 29 November 2017 to the Ministry of Foreign Affairs and Trade. Your request was partially transferred to my office on 13 December 2017, and seeks the following under the Act:

- 1. "A list of all reports, briefings and memoranda that the Minister of Foreign Affairs and the Minister for Trade have received since being sworn in.
- 2. A list of all meetings that the Minister of Foreign Affairs and the Minister for Trade have had with officials of the Government of the Russian Federation since being sworn in, broken down by subject matter and date, and copies of any documents created from those meetings.
- 5. A list of all meetings that the Minister of Foreign Affairs and the Minister for Trade have had with officials of the European Union since the current New Zealand Government was sworn in, broken down by subject matter and date, and copies of any documents created from those meetings.
- 8. Copies of any and all correspondence between the Minister of Foreign Affairs and the Minister of Trade and European Union officials regarding New Zealand-Russia economic/diplomatic relations and a potential FTA with the Russia-Belarus-Kazakhstan Customs Union."

Question 1 – For the reports, briefings, and memos received by the Minister for Trade and Export Growth between 26 October and 29 November 2017, please see the attached table. Some subject headings are withheld under the following sections of the Act:

- 6(a): to avoid prejudicing the international relations of the New Zealand Government;
- 6(b)(i): to protect the passing of information from another government on a confidential basis;
- 6(c): to avoid prejudice to the maintenance of the law; and
- 9(2)(a): to protect individuals' privacy.

Where the information has been withheld under section 9 of the Act, no public interest in releasing the information has been identified that would be sufficient to override the reasons for withholding it.

Questions 2 – I met with the Russian Minister of Economic Development, Maksim Oreshkin, in the margins of APEC on 8 November 2017 and in the margins 11th WTO Ministerial Meeting on 12 December 2017. I understand that a briefing Ministry of Foreign Affairs and Trade officials prepared ahead of APEC was released to you on 18 January 2018.

Questions 5 and 8 - Under section 18(e) of the Act, I am refusing your requests for information in questions 5 and 8 as this information does not exist.

You have the right under section 28(3) of the Act to seek a review of this response by the Ombudsman.
