1. Key decisions for you to make this week

1.1. Engaging with your colleagues ahead on Zero Carbon Act Cabinet paper

We consider it will be important to engage with your Ministerial colleagues ahead the taking the Zero Carbon Act paper to CBC in December. As such, we recommend that you consult with other Ministers on the contents of the Cabinet paper before Tuesday 28 November 2017. This enables you to provide final comments on the paper to officials by 4 December 2017, ahead of lodgement with Cabinet Office on 7 December 2017.

We recommended that you consult with the Minister of Finance, the Minister of Forestry, the Minister for the Environment, Minister of Energy and Resources and the Minister of Transport. If you agree, we will work with your office to schedule these meetings.

1.3. Forestry Unit Emission Trust – approval of new trustee

You will be asked to approve a new Trustee to the Forestry Unit Emission Trust this week. The Forestry Emission Unit Trust manages the allocation of New Zealand Units associated with Crown Forestry Licensed Land (CFL land) provided as a part of Treaty settlements.

CFL land is a significant part of New Zealand's pre-1990 forest estate. The Climate Change Response Act 2002 (the Act) provides for an allocation of 18 NZUs per hectare for eligible CFL land, which will become the property of the eventual landowners following Treaty settlements. Section 73 of the Act requires the Minister for Climate Change to appoint a person to apply for and manage these allocations on behalf of the future owners. The 'person' is the Forestry Emission Unit Trust.

One of the Trustees is now being replaced, which creates a need for you to withdraw the appointment of the Trustee, appoint a new Trustee, and have the change of Trustees notified in the Gazette. You will receive a briefing note in the next week with further information on Forestry Emission Unit Trust and attachments for your signature.

2. Material for you to be aware of this week

2.1. Climate Change Adaptation Technical Working Group - update

In November 2016 the Minister for Climate Change Issues established the Climate Change Adaptation Technical Working Group (the Group) to advise the Government on the options New Zealand has to build resilience to the effects of climate change. Judy Lawrence, Senior Research Fellow, Climate Change Research Institute, Victoria University of Wellington and Penny Nelson are Group's co-chairs. Current Group members include: Frances Sullivan, Principal Policy Advisor, Local Government New Zealand; Kirk Hope Chief Executive, BusinessNZ; James Hughes Associate Director – Climate and Resilience, AECOM; Bryce Davies, Senior Manager Government and Stakeholder Relations, Insurance Australia Group; Bruce Wills, Horticulture NZ Board, Motu Trustee and previous President of Federated Farmers; Sam Dean, Chief Scientist for the Climate and Atmosphere Centre, NIWA; Whaimutu Dewes, Lead Advisor to the Climate Change Iwi Leaders Group, and; Gavin Palmer, Director Engineering, Hazards and Science, Otago Regional Council. Last week you received a Briefing Note requesting a change in membership of the Group for Tina Porou to replace Whaimutu Dewes. The Ministry for the Environment provides Secretariat support for the Group.

The Group delivered their first, Interim Report, to the Previous Minister of Climate Change in May 2017. The interim report included a summary of the expected impacts of climate change on New Zealand over the medium and long term and a stocktake of existing work on adaptation. You will receive a final draft report, which aims to identify the options for how New Zealand can build resilience to the effects of climate change while growing the economy sustainably, by the end of November 2017 along with our advice on the actions it proposes. We have also factored some of the proposed actions into budget bids we are currently preparing.

The Group have requested a meeting with you in early December to discuss the report and proposed next steps. We recommend that you meet with the Group to confirm further action as the Groups' terms of reference also require them to produce a final report by March 2018.

2.2. Fonterra net zero emissions for operations by 2050 announcement

Fonterra announced their emission reduction targets and roadmap partnership with the Ministry for the Environment on 14 November 2017. The announcements have been well received with a number of media outlets focusing on Fonterra's ambition and net zero target. Criticisms have noted that the targets are a good first step but Fonterra must take immediate action to reduce their biological emissions and dairy herd. The Coal Action Network criticised Fonterra for not transitioning off coal sooner and continuing to burn coal.

The Bioenergy Association, however, says Fonterra's announcement sends a signal to industry that times are changing. Brian Cox, Executive Officer of the Bioenergy Association has praised Fonterra's intention to transition away from coal which he believes will provide positive stimulus for the wood fuel supply sector to meet fuel demand. Abbie Reynolds, Executive Director of the Sustainable Business Council, noted it was important not to

underestimate the significance of this step by Fonterra and that its actions displayed strong leadership which would be welcomed by many New Zealand businesses. Fonterra have been criticised by businesses in the past for not showing enough leadership in the climate change space but this announcement has been applauded by a number in the business community.

The Ministry is progressing action on the two actions it is responsible for under the Roadmap through existing work streams – a desktop report on the social good benefits of electrifying process heat and exploring new sources of capital and alternative financing models. The Ministry for Business, Energy and Innovation is currently reviewing the barriers for the uptake of renewable energy for process heat users under the Process Heat in New Zealand (PHINZ) plan.

2.3. Invitation for Prime Minister to attend French climate change summit

The Prime Minister has been invited to attend the "One Planet" summit in Paris on 12 December. The summit, co-organised by the United Nations and the World Bank and hosted by French President Macron, aims to strengthen the global political commitment for implementation of the Paris Agreement and push for progress towards a low-carbon economy. Leaders would be expected to participate in a high-level dialogue and join consensus on a leaders' statement, the text of which is not yet available. Officials will be submitting advice for the Prime Minister this week on attendance.

The summit is to be preceded on 11 December by a Climate Finance Day at which finance leaders will discuss the transition to a low carbon economy. The New Zealand Superannuation Fund has been invited to participate in a roundtable on the risks and opportunities presented by climate change, and has been asked to help develop a communiqué on integrating climate targets into investment decisions.



6.1. Key issues in the media and social media

- There was wide media coverage of the Prime Minister urging world leaders to join New Zealand in addressing the challenges of climate change. NZ was positioned as moving into a climate change advocacy and leadership role.
- Fonterra's announcement of greenhouse gas emission reduction targets received generally positive coverage in media and social media.
- Sea level rise was covered in a range of media outlets. Articles covered insurance issues for
 the Eastbourne community, the effects of sea level rise on Christchurch homeowners and
 Kapiti ratepayers taking their council to court over how it has dealt with coastal erosion. Some
 commentators called for central government support of councils.
