Test certifiers are required to enter into a register information for test certificates they have issued. The information entered by the test certifier for this event is provided overleaf.

Your request for the test certificate has been refused under section 18(g) of the Act because the information requested is not held by WorkSafe and I have no reason for believing the information is held by or connected more closely with the functions of any other agency that is subject to official information legislation.
