Part 1: Current priority outcome areas

Women's skills, employment, and income

National Council of Women workshop

We contributed our data expertise to a National Council of Women (NCW) workshop on economic well-being indicators. This is the first stage of NCW developing the business case for a gender equality dashboard. Participants included: Diane Ramsey, StatsNZ; economists Gail Pacheco and Prue Hyman; and representatives from the Salvation Army Social Policy and Parliamentary Unit, Human Rights Commission, and the Ministry of Foreign Affairs and Trade. We will keep you informed of progress.

NACEW letter of expectation

Your office has received a draft letter of expectation for the National Advisory Council on the Employment of Women (NACEW). The letter outlines how you would like to engage with NACEW over the coming year and your priority areas, as well as asking for information regarding any conflicts of interest. Once you have confirmed the letter, it will be sent to NACEW members, who will respond to you regarding any conflicts of interest.

Women's safety from violence

SkyTower lighting for awareness of gender-based violence

We contacted SkyCity Auckland with a request to light the SkyTower in orange to recognise the 16 Days of Activism against Gender-Based Violence, an international campaign which runs every year from 25 November to 10 December (Human Rights Day).

SkyCity responded that it was not possible to do this. However, the SkyTower will be changed to white this Saturday for White Ribbon Day and to align with SkyCity's internal launch of its domestic violence staff policy. We have passed on the contact person's details to your office, should you wish to arrange a visit at the weekend.

Youth Crime Action Plan group meeting

We attended a Youth Crime Action Plan cross-agency meeting to discuss the project we are scoping on young female offenders, which may include the link between victimisation and perpetration. The Youth Crime Action Plan is from 2013-2022. This group meets regularly to share insights about effective ways to address youth crime. Members include Ministry of Social Development, Ministry of Justice, Department of Corrections, Oranga Tamariki, and New Zealand Police. The group expressed strong interest in our proposed project and offered to provide us with useful data and contacts. We will continue to research and scope our project.

Other matters

Review of Property Relationships Act

On 22 November we met with the Law Commission regarding their research on the Property Relationships Act. In general, relationship separations have more adverse economic effects on women than on men, and it is not unusual for property to be used as a means of coercing or controlling someone in a relationship separation. This research is relevant to our work on both domestic violence and on economic independence; we will make a formal submission to the Law Commission in due course and will keep you updated on progress in this area.

Plain English Awards

On 23 November we will be attending the 2017 Plain English Awards. These awards are presented annually to public and private sector organisations that are raising the bar on clear communication. We are a finalist in the "Best Plain English Document — Public Sector" category, for our publication Closing the gender pay gap – advice for employers. We are also a finalist in the "Best sentence transfermation category.

Women in Sport

On 17 November we attended the *She Moves. She Leads. We Win.* Symposium (She Moves) held at Te Papa in Wellington. The event was hosted by organisations including Sport NZ, Wellington City Council, Women in Sport Aotearoa, the New Zealand Olympic Committee, Sport Wellington and EY. The aim was to stimulate discussion on equity, leadership and change. She Moves marked the announcement of a new partnership between Sport NZ and Women in Sport "Ngā Wāhine Hākinakina Aotearoa" to promote and advocate for women and girls in sport.

In his opening address Hon Grant Robertson, Minister for Sport and Recreation, stated that one of his main goals is to promote and support women in sport. We are working with Sport NZ to support efforts to improve the participation of women and girls in sport.

Tupu Tai Pasifika public sector intern programme

We are delighted that Sina Ete has joined the Ministry for 10 weeks as our Tupu Tai Pasifika policy intern. The Tupu Tai public sector intern programme, organised through the Ministry of Business Innovation and Employment, supports young Pasifika women and men into the public sector in policy, procurement and project management roles.

We attended Sina's induction on Monday morning and the launch ceremony in the evening. Hon Jenny Salesa and Hon Kris Faafoi spoke at the official launch ceremony.

Sina will work across the Ministry. We hope she will have the opportunity to meet with you and your staff.
