After Montenegro's independence, Serbia became the legal successor of Serbia and Montenegro, while Montenegro re-applied for membership in international organisations. In February 2008, the Republic of Kosovo declared independence from Serbia, leading to an ongoing dispute on whether Kosovo is a legally recognised state. Kosovo is not a member of the United Nations, but 109 states, including the United States and various members of the European Union, have recognised Kosovo as an independent nation.
