Hi Marie

OUT OF SCOPE

I wanted to put in a request to brief Minister Woods in her Research, Science and sections 9(2)(b)(ii) & 9(2)(ba)(i) Technology around a collaboration between New Zealand Government agencies and an exciting new project that intends to spark a world-first industry

The project is highly confidential and because of the commercial sensitivity, everyone who has been briefed so far has signed a Non Disclosure Agreement. However, below is

the high level -

- The project is being undertaken by Zephyr Airworks, the NZ arm of a Silicon Valley-based Zee. Aero a company that is looking to bring to market a revolutionary aircraft concept that will revolutionise the way we think about moving goods and people.
- The company has been developing the product for more than seven years in the US and last month the first vehicle was shipped to New Zealand.

Sections 9(2)(b)(ii) Z 9(2)(ba)(i)

- For the past months we have been working with the Civil Aviation Authority to achieve certification and have also started working with Government agencies and local providers to identify the jobs and infrastructure required for New Zealand to capitalize on this opportunity.
- Zephyr decided to come to New Zealand after a global search to find a jurisdiction that is safe, had aviation experience and was a good place to do business. It settled on New Zealand as the ideal location and has been working with MBIE, MoT, Airways, the Christchurch Mayor, Christchurch New Zealand and Christchurch International Airport for the past months. DPMC has also been briefed.
- We are also undertaking a significant investment in focus groups and research into public attitudes to the future of transport and we are sharing this with the New Zealand government.
- Successfully launching this type of vehicle is likely to be a world-first with the potential of spearheading a new industry in New Zealand and globally.



The President of Zephyr Fred Reid will be in New Zealand from 4 - 6 December and would be keen to meet with the Minister and show her some of our video footage and other collateral.

We are intending to launch early next year but are prepared to coordinate a date that is most useful for Government Ministers.

We would also extend an open invitation for the Minister to visit our facilities in Mountain View in Silicon Valley, adjacent to the Google Campus.


