31/01/2018 ACM detected and confirmed on another part of the building, School has decided to remove.

Reviewing the documentation relating the both the technical bloc and the boiler house asbestos removal work at Otamatea High School, located at 521 Bickerstaffe Road, Maugataroto, and in subsequent discussion with the contractors, assessors and school. It appears that the asbestos removal work was for non-friable asbestos containing material on the exterior of the building. ARCP appeared to follow ACOP and Regs, Clearance Reports have been issued for all work.

Based on the information I've received to date, it appears as though the contractors involved have met their duties under the Health and Safety at Work Act 2015 and the asbestos regulations 2016, except as noted below.

The Otamatea school board of trustees/ Ministry of education appear to have failed in their duty under section 36 of the health and safety at work (Asbestos) regulations 2016, in that they did not inform certain persons about intended asbestos removal work, in this instance their staff on site.

I am following up with the school in regards to its failure to notify affected persons.

Further testing is being undertaken at the moment to confirm the site is clear from any asbestos related risk to the health and safety of persons who may use this area in the future.

Part of the complaint relates to the lack of air monitoring during the removal work, Only friable A class work requires this under the Health and safety at work (Asbestos) regulations 2016. The MoE has decided to implement air monitoring on ALL asbestos removal jobs on it property, the contractors have failed to meet this MoE requirement at this school. this requirement is not enforceable under the HSWA (Asbestos) Regulations 2016.

We were contracted by ARCO to remove external B Class asbestos cladding, at the time the job was started the school was shut and the building/block isolated from ALLEASED UNDER THE OFFICIAL the remaining areas of the school. My NI Manager phoned and asked about perimeter monitoring, I made the call not to do this due to the school being closed, the type of product and because the sheets were able to be removed whole so minimal disturbance. At the time of removal the weather was not a factor/concern, plastic drop sheets were installed and the sheets were sprayed prior to

removal, as the sheets were removed they were placed on heavy 200mu plastic, wrapped and placed on the truck for transport. Once the removal was completed Interteck completd a viual inspection prior to sign off/handover to ARCO
