Dear Mr Ecclestone

Official Information Act request for documents relating to Law Commission recommendation 37

I refer to your emails of 11 May 2018 to the Ministry of Justice and the Minister of Justice, seeking under the Official Information Act 1982 in electronic form:

- "All documents, emails, memoranda, briefings, aide memoire, speaking notes, notes of meetings, handwritten notes made by officials, or other recorded information held by the Ministry, that includes any consideration of Law Commission recommendation 37 on deleting the Ombudsman from the list of entities excluded from the definition of 'agency'; and
- Copies of all correspondence and notes of meetings (handwritten or typed up) that relate to this issue, that the Ministry has held with:
 - o The Ombudsman or any of his employees or representatives;
 - The Privacy Commissioner or nay of his employees or representatives;
 - Any other third party."

The table included in Appendix A sets out my decision about whether to release these documents to you. Released documents are provided separately.

Recommendation 37 was modified by Cabinet to instead amend the Ombudsmen Act 1975 so that information on how the Ombudsmen deal with personal information would be included in their annual report. I note that this modified proposal has not been included in the Privacy Bill as it is an amendment to the Ombudsmen Act that is not consequential on the other reforms of the Privacy Bill.

You have the right under section 28(3) of the Official Information Act to complain to the Ombudsman about the decision to withhold some of the information requested.
