On 19 May 2018, you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

• A list of all briefings relating to the housing portfolio.

Your request has been interpreted as regarding briefings provided to the Minister for Housing and Urban Development. Please find enclosed a list of reports, briefings and aide memoires sent by the Ministry to the Minister of Housing and Urban Development between between 26 October 2017 and 19 May 2018. The Ministry also provides input into weekly updates regarding this portfolio, titled 'Housing and Urban Development Update'.

You will note that eight titles have been withheld partially or in full under section 9(2)(f)(iv) of the Official Information act as information in the title is under active consideration. The release of this information is likely to prejudice the ability of government to consider advice and the wider public interest of effective government would not be served.

Please also note, one title is partially withheld under section 9(2)(a) of the Act to protect the privacy of an individual. An additional title is withheld under section 9(2)(j) of the Act to enable the Ministry to carry on, without prejudice or disadvantage, negotiations (including commercial and industrial negotiations). The greater public interest is in ensuring that government agencies can continue to negotiate without prejudice.

Should you wish to request a copy of any of the listed briefings please contact OIA Requests@msd.govt.nz and the paper will be assessed for release. Please note that the information in the 'Housing and Urban Development Update' update is expressed in an informal and frank manner, and is a means of ensuring that the Minister is briefed in advance of a full report on the issues being received. The release of this information is also likely to prejudice the ability of government to consider advice and the wider public interest of effective government would not be served. The need for confidentiality will diminish over time and in light of other events, and I would be willing to reconsider whether ongoing withholding is necessary three months after the date an update was tendered.
