Apologies for the delayed response – we've had quite a bit going on this past couple of weeks!

I'm reaching out because I'd really like to get some of the work we discussed when we met in October underway.

At least in part, my hope is that I can get

off our case by meeting the targets in one foul swoop!!

To that end, I've asked Sarah Davy, my GM of Information Services to reach out to Phil Hobden and get the following things underway asap.

- Agreement about which fields from the Basis Database TVNZ is comfortable with Ngā Taonga publishing on it's website
  - O At a minimum we would need Title, year of production but ideally we'd like to include more than that (e.g. most fields but excluding shot lists)
- Confirmation of the file formats for programmes that are included in your DPL from our discussion I understand there are two formats one is a broadcast quality version that your producers use, and the other is a higher resolution format for archival purposes. Confirmation of the formats and compression types would be very helpful (particularly the higher resolution format)
- Agreement to start providing Ngā Taonga with digitised files that are older than five years old (we'll cover the costs of hard-drives etc)
- An up to date list of what material is in the DPL so that we can start comparing notes and prioritising digitisation of material that *isn't* in the DPL.

These things are in order of importance. If we can agree the database fields quickly, then our team can start the process of uploading viewing files that are older than five years old (consistent with our agreement) and already digitised by us.

I really appreciate your assistance with this! It would be exciting to get this underway.

Please know that we will be very mindful of copyright in relation to titles that TVNZ does not own the copyright for.



Notes from TVNZ/Nga Taonga Meeting at TVNZ, Hobson St, Auckland 1 February 2018 1300-1415

In attendance: Phil Hobden, Lauren ...., and Lindsay Chalmers (TVNZ), Sarah Davy, Steve Russell and James Taylor (Nga Taonga Sound & Vision).

# TVNZ/Ngā Taonga Production Library Services Agreement (2014)

• Retrieval and delivery of Archive Collection material for TVNZ TVNZ happy with existing timeframes for service delivery. Request from TVNZ for Nga Taonga to investigate change for delivery for licensing requests from two days to one [see below on TVNZ/Getty]. TVNZ advised that line feed mechanism is not going to change to Aspera digital delivery in the imminent future, and will give Nga Taonga plenty of notice: issues such as band\_with need to be addressed. Ideally any changes to line feed mechanism can be aligned to Nga Taonga's existing digital delivery platforms

Action: James to research feasibility of changing from two day turnaround to one, and advise Phil Hobden.

## Digitisation

Nga Taonga explained transition from telecine to scanning for preservation [from film] at Avalon, which means better quality material for TVNZ, which may impact delivery times for material originating on film.

- Cataloguing and metadata exchange
- Exchange of digitised material

Agreed that this is still a relevant area to include in the future agreement. TVNZ and Nga Taonga to keep this option open, accounting for potential movement of material from DPL once it is no longer commercially useful, out of licence, fully funded by NZoA or TMP etc., to export to the collection at Avalon. A small subset of collection material will always be retained by TVNZ in the DPL, for example that with legal issues/other sensitivities. Issues here to resolve include differences in file formats, and metadata schema between the systems used by each party. This will be the subject of a future working party. Both parties keen to keep the delivery infrastructure simple.

Action: Phil Hobden to provide examples of the DPL metadata schema to Nga Taonga.

#### Transfer of TVNZ Archive Collection and Employees (2014)

• Implications of putting the Ngā Taonga Archive Collection database and collection online.

Nga Taonga Plan to put database and content online as outlined in email of 15<sup>th</sup> December is agreed. This content will exclude titles on the DPL [excepting copies released from DPL and ingested into Archive Collection. There is a corresponding piece of work required around workflow, and how commercial third party requests will be directed back to TVNZ/Getty. Members of the Public (MoPs) agreed to be supplied by both parties: Nga Taonga will put items online to service these at no charge, and TVNZ will charge for MoPs for material that comes from the DPL.

Action: Joint working group to be convened to cover mutual workflow issues: to include relevant TVNZ staff, James Taylor from Nga Taonga and others TBC. To cover discussions of the working groups (any or all of the above) TVNZ to set up a Non-Disclosure Agreement about this work.

# Watermarking

Agreed that all material from the Archive Collection online is to be watermarked (no exceptions as per existing agreement).

• Pre-approval process for non-commercial third-party research and access Nga Taonga requested to be able to offer non-commercial research and access to the Archive collection. Non commercial includes iwi, educational, community groups, GLAM and Not For Profit sector i.e. the 'public good' space. TVNZ potentially comfortable with this, as long as TVNZ is credited: these uses may fall under the Getty definition of 'personal': criteria to be clarified through ongoing TVNZ negotiations with Getty. Nga Taonga explained the RNZ model of licencing which they successfully administer, which has a threshold of payment and contact back to RNZ.

Action: TVNZ to confirm the criteria and ethos for Nga Taonga to supply.

- Ngā Taonga organisational use of Archive Collection TVNZ potentially comfortable with this, as long as TVNZ is credited and contacted in each case as a courtesy, so they are aware of the nature and purpose of the request.
- Kaitiaki clearances for Māori material Information, rarely from experience documented, about this is with producers of the programmes.

Action: Lauren to supply lists of contacts of producers for Maori programmes, whether in house or now commissioned, to Nga Taonga.

#### Other

• Exchange of statistics

Nga Taonga require statistics of viewers for programmes where Nga Taonga had supplied material (broadcast and online). This would not be publicly available or broken down, but anonymised and amalgamated with other statistics around 'reach' for official reporting to MCH.

Nga Taonga is working on overhaul of statistics, changing those that are collected so they are mutually beneficial.

Actions: Phil Hobden to discover whether TVNZ can supply viewing statistics.

James Taylor to supply Phil Hobden with Nga Taonga statistics quarterly.

• Archive Collection stills and documentation

Nga Taonga explained about the stills and documentation collection which requires an audit, preservation and cataloguing.

# • Implications of TVNZ/Getty partnership

Negotiations between TVNZ and Getty underway. Getty, as TVNZ's commercial licencing 'Front of House' will licence TVNZ DPL material. For the majority of cases footage will be licensed and supplied from shop front selection (30-60 seconds "stock" footage) available of download from Getty's platform. Where Getty require research into Archive collection these will be fed to Avalon and back through TVNZ in current manner (hence need for 1 day turnaround).

Actions: TVNZ to advise when negotiations are complete, through general stakeholder comms.

Working Group to convene about related workflows across the two organisations, as above.

## Charges

Nga Taonga explained its charging review, which may mean the two organisations are charging differently for TVNZ material.

Action: Phil Hobden to review MoP charges from the TVNZ side

#### Contacts

Nga Taonga requested confirmation about contacts at TVNZ: Phil Hobden is the key TVNZ contact person, Brent McAnulty is the TVNZ relationship manager, and Sarah Davy the Nga Taonga relationship manager.

**Subject:** Relationship Map and Working Party

Hi Phil

Thanks for your email.

James has advised, in answer to your question, that our Client Access Liaison team are generally guided by TVNZ licensing when providing material from the Archive Collection to external parties. The only exceptions would be MoPs, NZ on Screen and very occasional MTS requests. For requests for internal use by Ngā Taonga (e.g. on-site screenings) the CAL team follow the guidelines as set out in the Transfer Agreement. Any restrictions are primarily based on copyright or other restrictions as noted in the database. As this is a case by case process, we don't have any formal processes around this apart from checking the copyright metadata we have and going back to production contracts if necessary, and blanking out any restricted footage. In general, the same conventions are in place as when TVNZ directly ran the Archive Collection. We'd like to see the relationship map when the draft is complete.

At our 1 February meeting we agreed to put together a working party about workflows around the new interaction between yourselves and Getty Images and the flow on to Ngā Taonga, as Archive Manager — please can you confirm the status of this, as we are keen to contribute to this to ensure we make progress and that the solutions are as workable as possible. For example we will need to discuss your request for a change from the current two-day turnaround to one day, to be clear about what the expectations are: at this point this will not be possible within our current resourcing and staffing levels. We also need clarity about the details of the following:

- Workflow and criteria for non-commercial re-supply
- Workflow for MoP requests
- Exchanges of statistics, material and metadata
- Mechanism for noting new restrictions across all databases

We said we'd meet up again in April, at Ngā Taonga — at the moment we can do the following: Monday 9 April am or pm, Wed 11 April at 10am, Monday  $16^{th}$  April am/pm and Wednesday  $18^{th}$  April am/pm. Let me know a date that suits, and I'll arrange things this end.

Hi James,

Hope this email finds you well.

I'm just putting the finishing touches to a Relationship Map which details the interaction between ourselves, Getty Images and Nga Taonga to give some clarity for our internal stakeholders.

One of the key objectives of this Relationship Map is to provide assurance that there are editorial checkpoints in place prior to any material released to external clients such as TVNZ Commissioned Producers and Members of the Public. An example of these check points are two we will have with Getty Images regarding licensing requests. The initial check point will be when we receive the request for footage — we'll assess whether the request is for commercially or culturally sensitive material and make the decision then whether to proceed or not. The second check point will be when we have conducted the research and identified the footage available — we will again have the opportunity to select or remove content based on commercial or cultural sensitivity.

Rather than make assumptions I wanted to check with you what your current guidelines are for providing material from the TVNZ Collection to external parties. It may be the same general check points as I have mentioned above but would appreciate some clarification please.

Subject: TVNZ Content Storage

Hello Sarah and James

Phil Hobden, TVNZ's General Manager of Media Operations, has asked me to contact you with regard to three TVNZ videotape/DVD collections stored at the Television Centre in Auckland.

Our current storage facility does not provide a suitable environment for these valuable collections and we would like to look into the possibility of moving them into the TVNZ Collection at Nga Taonga.

The first collection comprises as-broadcast recordings of TVNZ Current Affairs programmes, dating from 1991 to 2008 (approximately 2,000 Betacam SP videotapes). It includes all episodes of programmes like "Eye to Eye", "Crossfire" and "Fraser" from that period. These programmes are also held within the former TVNZ Archive collection at Nga Taonga, but it may be advisable to have back-up copies or there may be missing episodes.

The second collection comprises as-broadcast recordings of the Breakfast/Business news programmes from 2007-2011 (approximately 1,300 VHS videotapes and DVDs). They're occasionally re-used – generally during significant

anniversaries of the programme. A Betacam SP/SX recording of one episode per fortnight was made and sent to TVNZ Archive, but for all other episodes, the VHS/DVD recordings are the only copies in existence.

The third collection comprises as-broadcast recordings of the "Te Karere" news programme from 2001-2005 (approximately 330 VHS videotapes). They're occasionally re-used – generally during significant anniversaries of the programme. TVNZ didn't start making Betacam SX recordings of "Te Karere" until 2006, so these VHS recordings are the only copies which exist for the early to mid 2000s.

As always, our intent is to collaboratively work with you to preserve New Zealand's broadcasting heritage and we'd appreciate your support of the aforementioned proposal.

The key points:

#### **FOOTAGE LICENSING REQUESTS**

As discussed, all requests for TVNZ footage will be directed to Getty Images. TVNZ DPL Team will receive the client request from Getty's and process accordingly. The TVNZ DPL Team will liaise with the team at Nga Taonga for any footage that only resides in Avalon.

The TVNZ DPL Team will conduct three editorial check points as part of our content supply governance.

#### TVNZ COMMISSIONED PRODUCERS

All requests for footage for TVNZ commissioned programmes will be directed to the TVNZ DPL Team. If content only resides at Nga Taonga the client will be directed to the Team at Nga Taonga to fulfil the request directly with the Commissioned Producer.

Two editorial checkpoints are included within the workflow.

#### MEMBERS OF THE PUBLIC REQUESTS

All requests for footage from MOP's will be directed to the TVNZ DPL Team. If content only resides at Nga Taonga the client will be directed to the Team at Nga Taonga to fulfil the request directly with the member of the public. Two editorial checkpoints are included within the workflow.

Please be assured that these changes will not result in additional work for Nga Taonga.
