Thank you for your request of 3 August 2018 requesting:

Under the OIA, I request a copy of the Annual sodium fluoroacetate (1080) notifications for the last 2 years.

This information is provided in the form of a summary table as agreed in your email of 15 August 2018, and should be read in the context of the following explanation about the legal framework surrounding the use of 1080 in New Zealand.

1080 is legally allowed to be used in New Zealand under controlled circumstances. WorkSafe undertakes its obligations in that context and until the current approvals are revoked or changed, will continue to do so. WorkSafe is not the agency responsible for making decisions about whether the product should or should not be used in New Zealand – that is the responsibility of the EPA.

The requirements for managing the supply, manufacture, storage and use of 1080 are governed by the **Hazardous Substances and New Organisms Act 1996 (HSNO Act)** and the **Health and Safety at Work (Hazardous Substances) Regulations 2017**. HSNO covers the approval of 1080 for use in New Zealand; non-work, public health and environmental risks; and specific requirements on importers and manufacturers of hazardous substances.

In the case of 1080, enforcement under the HSNO Act is divided between several enforcement agencies:

- **The Environmental Protection Agency (EPA)** is the primary agency, and approves the use of 1080 in New Zealand, and oversees enforcement by the other agencies.
- The EPA has delegated the function of granting, varying and revoking permissions for the use of 1080 to **Medical Officers of Health and Health Protection Officers**.
- **Ministry of Primary Industry (MPI)** is responsible for enforcing the Agricultural Compounds and Veterinary Medicines Act 1997.
- **Department of Conservation (DoC)** is responsible for issuing permissions to use 1080 on DoC-administered land.

Pest Control Operators are directly responsible for managing the risks of 1080, including reporting any incidents involving 1080 to the appropriate enforcement agency.

WorkSafe cannot respond to concerns raised by the public about 1080 drops that are outside of its jurisdiction. If the concern raised does not directly relate the signage requirements for the use of 1080; the requirements for aircraft carrying out aerial application of 1080, or the requirements for restricted access to the vicinity in which 1080 is applied then WorkSafe must refer the concern on to the appropriate agency as specified in the relevant legislation.

Many of the notifications listed in the attachment fell outside of WorkSafe's jurisdiction. Some could not be investigated due to evidential insufficiency and the other notifications were referred on to the appropriate agency to investigate.
