Official Information Act request: ROC*ROI algorithm and seriousness of offence scores

Thank you for your email of 29 August 2018 to the Department of Corrections requesting, under the Official Information Act 1982 (the Act), information regarding ROC*ROI algorithm and seriousness of offence scores. On 3 September 2018, the Department of Corrections responded to part one of your request, Q1) Is the ROC*ROI algorithm still the same as that mentioned in the following 2012 document from the Department of Corrections:

https://fyi.org.nz/request/501/response/4002/attach/4/Attachment%20C59531.PDF.pdf? If not, please could you provide an updated version of this algorithm, and transferred parts two and three to the Ministry. Please find answers to your specific questions below.

2. Given that the scores of the seriousness of offences have been updated since 2013, have the numeric weightings in the ROC*ROI algorithm (i.e., all the numeric values in the PDF document linked to in Q1) been updated in any way too? If the numeric weightings in the ROC*ROI formula have been revised, please could you provide the revised version of the ROC*ROI algorithm with the current weightings.

The Department of Corrections have outlined in their response that the seriousness of offence scores in the ROC*ROI algorithm is updated whenever the Ministry updates the scores. The Ministry completed a full refresh of seriousness score in 2016. Since then a number of new offence codes have been added for which seriousness scores have been calculated. The Ministry provides the Department of Corrections with a six-monthly updates of offence code information, which includes, the values of seriousness score.

3. An updated table of the scores of the seriousness of offences was released in May 2017 (https://www.parliament.nz/en/pb/order-paper-questions/written-questions/document/QWA_02191_2017/2191-2017-darroch-ball-to-the-minister-of-justice). Given that these scores are inputs into the ROC*ROI algorithm, please advise whether these scores are still accurate. If the scores are no longer accurate, please could you provide an updated table of scores.

The seriousness scores published are those currently used by the Ministry. However, since May 2017, there have been new and updated offences for which new seriousness scores have been calculated. Seriousness scores that differ from those published, including new offence codes, have been provided in the attached document. Please note that these new seriousness scores were calculated using the same data as those calculated in the 2016 seriousness score update (using 2015 data). For new offence codes that have been enacted since 2015, the seriousness score is assigned based on the Australian and New Zealand Standard Offence Classification grouping for that offence.
