OFFICIAL INFORMATION ACT REQUEST

I refer to your official information request on 2 October 2018 for the following:

Please supply all notes taken at, and documents (including emails) held by the Ministry for Primary Industries (MPI) in relation to the Emergency Management Adult Community Education (EM ACE) governance group meeting held in September 2018; and whether any conflicts of interest were disclosed by representatives of the Ministry.

No staff members from MPI attended the EM ACE governance group meeting held on 18 September 2018, and therefore, MPI do not hold documents on, or notes taken at that meeting. MPI did consider transferring this part of your request to the other agencies who did have staff members in attendance. However, as I understand you have made this same information request to a number of other agencies, I did not feel that transferring this part of your request was necessary.

Under the Official Information Act 1982 (OIA) I am releasing to you a pack of email correspondence that was sent to and from MPI staff members on the topic of the governance group meeting. Some information has been withheld under section 9(2)(a) of the Official Information Act 1982 (OIA), to protect the privacy of natural persons.

MPI met with the Tertiary Education Commission (TEC) and the Ministry of Civil Defence and Emergency Management (MCDEM) for the first time on 13 September 2018, prior to the aforementioned governance group meeting. This meeting was to establish next steps for these groups to consider any applications that may be forwarded for consideration for funding from the EM ACE fund.

MPI did not declare any conflicts of interest, as there were none identified as relevant. The meeting was to meet key participants and establish next steps in light of the announcements made in the media and social media by Animal Evac and Gareth Hughes in regard to the EM ACE fund.

MPI is satisfied that in the circumstances of this case, the withholding of the information is not outweighed by other considerations which render it desirable in the public interest to make the information available. You have the right under section 28(3) of the OIA to seek an investigation and review by the Ombudsman of our decision to withhold information.

I have a number of reflections for you to consider. This may be part of your messaging or something we catch-up on next week, but we do need clarity of roles and functions in this space before the Governance Group meeting. Having multiple funding applications come to the EM ACE Fund Governance Group is not the solution. There needs to clarity around a number of operational aspects before funding is allocated.

- How will MPI endorse / vet the applications for funding of animal welfare training? We know of one organisation which intends to apply and a second is making enquiries.
- How do we as CDEM have confidence that the respective animal welfare organisations are credible organisations with official roles and responsibilities in a response? How does MPI plan to include them in their planning?
- What training is to be funded in terms of unit standards or other? Again what has MPI approved in this space?

While TEC can provide the guidelines concerning the eligibility of the fund, they do not know the CDEM operational landscape - we need to follow the stipulations as laid out in the National CDEM Plan. Without the above clarity the Governance Group will not have the information it requires to consider applications from animal welfare/rescue organisations.

Happy to discuss this further or catch-up face to face next week.







- How do we as CDEM have confidence that the respective animal welfare organisations are credible organisations with official roles and responsibilities in a response? How does MPI plan to include them in their planning?
- What training is to be funded in terms of unit standards or other? Again what has MPI approved in this space?

While TEC can provide the guidelines concerning the eligibility of the fund, they do not know the CDEM operational landscape - we need to follow the stipulations as laid out in the National CDEM Plan. Without the above clarity the Governance Group will not have the information it requires to consider applications from animal welfare/rescue organisations.

Happy to discuss this further or catch-up face to face next week.


I wanted to let you know that we've secured access to training funding for animal evacuations!
