2.1. CCATWG report responses

The release of the Climate Change Adaptation Technical Working Group has been covered by most major news outlets. Those who covered it were OneNews, NZ Herald, Stuff (The Press, Waikato Times and Dominion Post), Hawkes Bay Today, Radio New Zealand, Maori TV, Carbon News and Newstalk ZB.

Around half of the coverage was negative with a focus on what the news outlet saw as the group's criticism of government over inaction or lack of planning. WWF says the Government needs to do more. The rest of the coverage was neutral or positive.

An editorial from the Dominion Post summarised the issues particularly well. A group of Hawkes Bay communities banding together to look at climate change adaptation welcomed the report.

2.2. Claims that ruminant livestock are greenhouse neutral are misleading

Recent opinion articles and enquiries to the Ministry have included the claim that ruminant livestock are greenhouse neutral. This claim is used to argue that agriculture should not be included in the ETS.

There are two aspects to the claim. The first is that ruminant methane comes from carbon that the animal has eaten as pasture, which was in turn extracted from carbon dioxide in the air. Because the methane in the atmosphere decays back to carbon dioxide over several decades, some people regard this as a "greenhouse-neutral" cycle. This is not the case, because methane is a much more potent greenhouse gas than carbon dioxide. Ruminant livestock convert pasture to methane, contributing to global warming. Research suggests that non-CO₂ emissions from livestock globally have caused about 20 per cent of the total warming so far.

The second aspect is that if methane emissions are constant, then they cause no further warming. Broadly, this is correct. Because methane is a short-lived gas, it does not accumulate in the atmosphere in the same way as carbon dioxide. A constant level of emissions results in constant concentration in the atmosphere (after several decades). This results in a stable contribution to warming from the methane, although this takes more than one hundred years. Recent research also indicates a small ongoing warming effect due to feedbacks in the climate system. Due to the past increases, New Zealand livestock emissions are still contributing further warming.

Irrespective of whether or not agriculture in New Zealand is contributing to further climate change, reducing methane emissions from agriculture would still help to limit further warming. As this is our main goal under the Paris Agreement, it makes sense to reduce emissions from all sectors, including methane from agriculture, where it is cost-effective to do so.

We expect that the wider issues of agriculture and methane will be prominent for the next few months (at least). Officials are willing to brief you on these issues, and will be prepared to discuss them during the upcoming public consultation on the Zero Carbon Bill.

2.3. New Zealand joins Electric Vehicle initiative

With Minister Woods' agreement, New Zealand has joined the Electric Vehicle Initiative (EVI), a programme under the Clean Energy Ministerial forum. EVI membership will link New Zealand into international best practice around electric vehicles (EVs), including policy, research and information sharing with major EV producers and markets. Other members include Canada, China, Finland, France, Germany, India, Japan, Mexico, the Netherlands, Norway, Sweden, the UK, the US and the European Union. MBIE and EECA will lead on the Government's engagement in the EVI, with support from MFAT. Domestically, EECA supports the Government's Electric Vehicles Programme through an information campaign and a Low Emission Vehicles Contestable Fund.

2.1. Zero Carbon Bill update

On 6 June we spoke to you about the timeframes for the Zero Carbon Bill including the detailed steps it will take to reach final policy decisions.



We provide regular updates on the progress of the programme and will make all efforts to make efficiencies where possible.

2.2. New research supports stabilisation target for methane

A study published last week introduces a new method to compare how methane and other gases contribute to greenhouse gas emissions budgets. Compared to the currently adopted metric, this new method reduces the significance of methane in all-gases budgets or targets proposed to achieve the goals of the Paris Agreement. It also supports stabilisation targets for short-lived gases and zero-emissions targets for long-lived gases. The study was co-authored by Professor Dave Frame (VUW) with colleagues from the UK and Norway, and he is likely to publicly advocate these ideas during the current consultation on the Zero Carban Bill.

These issues have been discussed in both the Productivity Commission report and the discussion document for the ZCB consultation, and the separate treatment of methane is already a key component of the consultation.

2.4. Government Policy Statement on land transport 2018

Following from the public consultation phase of the Government Policy Statement on land transport (GPS), Minister Twyford intends to lodge a finalised version of the GPS with Cabinet Office on 14 June (with cross party consultation occurring from 4 June – 12 June and it going to DEV Committee on 20 June). The public consultation process saw over 900 submissions through a four week engagement process. Following this, the GPS has been revised to take into account public feedback and more recent Government announcements related to the land transport system. The Ministry has been consulted on both the revised GPS and the accompanying Cabinet paper. Notes of importance between the GPS provided for public consultation and the current one include:

- The four overall strategic priority areas of safety, access, environment and value for money which previously had equal focus has now been broken down into key priorities (safety and access) and supporting priorities (environment and value for money). The reasoning provided for this was that many submitters specifically endorsed a new safety strategy and agreed that increased investment in active modes (walking and cycling) and public transport was long overdue in urban and regional New Zealand. Environment and value for money priorities have been deemed to be considered more 'at the heart of how safety and access are achieved.'
- Prioritisation of reducing GHG emissions from transport and supporting a mode shift to lower emission forms of transport still remains a key focus. As does linking expenditure and policy decisions with achieving the Paris target and the future 2050 target.
- A language change from 'mitigating climate impacts' to 'reducing GHG emissions.'
- The current GPS will now show even further overall funding for expenditure on walking, cycling
 and public transport (this is mainly due to the draft GPS being released prior to Cabinet agreeing
 to the ATAP package, so an increase in the final GPS will provide sufficient funding to support
 delivery of ATAP and other public transport priorities outside of Auckland).

Plans also remain for a second stage GPS that would likely release in 2019. Transport officials have previously detailed that this could allow for further work relating to specifics of meeting emission reduction targets as well as looking into future rail projects and support of costal shipping.

2.5. Update on DIA led Community Resilience Group and CCATWG response

In our 17 May briefing "Next steps for a government response to the Climate Change Adaptation Technical Working Group Recommendations Report" we said that we intend to coordinate with the DIAled work on community resilience to respond to the CCATWG recommendations.

The Community Resilience Group, led by DIA, has now been formed. The group includes members from Treasury, MBIE, MCDEM, MFE, DPMC and DIA at both a working group and Deputy CE level.

The group's immediate priority is to advance options for the management of natural hazards in Kaikōura. As part of the advice on this topic, a Ministerial grouping will be proposed to discuss the Kaikōura options as well as the wider community resilience work programme. This Ministerial grouping should include the Minister for the Environment and yourself as Minister for Climate Change.

After this initial advice, the Community Resilience Group will give longer-term consideration to issues relating to resilience, including considering managed retreat options, and advancing a government response to the CCATWG recommendations report. Specific actions the group has already identified as particularly relevant to its work include: establishing governance arrangements (action 5); a centralised service for expert advice to local government (action 13); and defining funding arrangements for climate change adaptation (action 16). We will continue to engage with this group and update you on progress.

2.6. Environmental Audit Committee releases report pointing to inadequacies in the UK's framework of financial regulation in relation to climate risk

The UK House of Commons' Environmental Audit Committee (EAC) has released its final report as part of its Green Finance Inquiry. This report is titled 'Greening Finance: embedding sustainability in financial decision making'.

The EAC has called on the UK government to set out its expectations that listed companies and big investors should all be reporting on climate risk now, in line with best practice guidelines laid out by the Task Force on Climate-Related Financial Disclosures. They also recommend that the government make such reporting mandatory (on a "comply or explain" basis) by 2022 as a longstop.

A number of recent reports have also highlighted that entities are obligated to report material financial risks, yet there is a lack of understanding or willingness to accept that climate risks are (or can be) material financial risks.

The report also notes that any climate risk disclosure requirements should apply equally to asset owners (such as pension funds) as well as their investment managers, not just listed companies. We will keep these issues in mind as we continue to scope out further work on climate risk disclosure with the Ministry for Business, Innovation and Employment.

2.7. New research finds that technology change rather than climate policy is critical to the potential financial risks involved with the transition

New research undertaken by a collection of universities supports the idea that a carbon bubble exists. The study published in *Nature Climate Change*, argues that if this bubble is not deflated early, it could wipe trillions from the global economy, with major macroeconomic and geopolitical consequences.

This new research argues that technological change alone, even in the absence of new climate policies, could reduce global demand growth for fossil fuels to the extent that significant assets are stranded. Examples of such technological change are technologies in renewable-energy deployment, transport electrification and household/vehicle efficiency that become more efficient and therefore diminish the use of fossil fuels. Until now, observers have cited the unlikely effectiveness or timeliness of climate policies as a reason to not take the carbon bubble seriously. However, this research argues that there may be a failure to recognise the role of the ongoing technological transition on the risks of asset stranding.

The research also finds that by not promoting low-carbon technologies, countries will miss out on job creation opportunities and opportunities to reduce domestic fossil fuel demand.

2.2. The Land and Water Forum

In December 2017, Hon Parker's requested advice from The Land and Water Forum on avenues to avoid further degradation of freshwater environments and on catchment allocation of nutrients and sediment. The Forum was set up in 2009 as an independent advisory body funded by MfE. It represents a range of stakeholders including industry groups, electricity generators, NGOs, iwi, scientists, and other organisations with a stake in freshwater and land management. The Forum has now responded to this request. Their response included minor components related to the One Billion Trees programme and how the NZ ETS works for small-scale forests, as part of wider recommendations around erosion management. MfE is currently preparing advice for Hon Parker on the recommendations put forward by the Forum.

International

2.3 Climate change statement from G7 meeting

G7 leaders held their annual summit, 8-9 June, in Quebec, Canada. In the Communique from the meeting, G7 leaders found common ground in noting the mutual benefit of a healthy planet and sustainable economic growth, action to strengthen collective energy security, recognition that each country may chart its own path to achieving a low-emissions future, and looking forward to adopting a common set of guidelines at COP24 (without reference to the Paris Agreement).

The "G6" reaffirmed their strong commitment to implementing the Paris Agreement and reaching a global carbon neutral economy over the course of the second half of the century, ensuring a just transition, and increasing efforts to mobilise climate finance. The "G6" also discussed the importance of carbon pricing, technology collaboration and innovation to continue advancing economic growth and protecting the environment.

A separate paragraph reiterated the US' commitment to advancing sustainable economic growth and strengthen collective energy security, in a manner that improves the health of the world's environment;

it noted the US' intention to work with other countries to access and use fossil fuels more cleanly and efficiently, as well as deploy renewable and other clean energy sources. Other aspects of the communique included "investing in growth that works for everyone" and "preparing for jobs of the future".

2.1. Zero Carbon Bill Meetings and Submissions

As at 9am Thursday 21st we have received 1,194 submissions. Approximately three quarters of the submissions are based on templates prepared by Generation Zero and WWF NZ

We have reached a lot of people online, mainly through Facebook. We've reached 344,442 people in June, with 8.53K comments, 2.49K shares and 41K reactions. The 'Our Climate, Your Say webpage has received 10,293 page views, and the discussion document 3,229 page views.

We have held five public meetings so far.

Whangarei, 8 June: Around 110 people attended. The crowd was largely supportive and questions mainly covered the longevity of the Commission and the importance of bipartisan support; whether or not methane should be included, and the impact on low income families.

New Plymouth, 11 June: About 75 people attended. Lots of residents and about half a dozen businesses in the audience. There was a positive tone from the crowd and key questions included, whether there could be a blend between target options B and C, why the consultation was necessary when a target of 'net zero' could just be set; and, what the options are for sequestration.

Hamilton, 14 June: About 70 people attended, a mix of farmers, business, innovators and general public. First crowd that included people who denied the science of climate change. Other questions included, what have we spent on climate change already, efficient farming practices and food production, ensuring impartiality of the Commission, storing carbon in soils, education and power of local councils to take action.

Gisborne, 18 June: Around 55 attended, mix of local leaders, residents and farmers. Questions around methane, can we make a difference as a small emitter, and potential for trees already in the ground to be counted. Regional difference — theme, people aren't keen on having more forestry in Gisborne. They feel that will impact on community on the East Coast. "We don't want to have to pay for Auckland's emissions by planting trees."

Hawke's Bay, 19 June: Around 65 people attended, a mix of farmers and general public. Key themes were around how we are consulting with iwi; the innovation already happening in the agricultural sector and how this will take us to a net emissions 2050; our international competitiveness; soil carbon; education and whether methane is stabilised at today's level or below.

We held our first technical workshop in Wellington on 20 June with 60 attendees, which was a very constructive conversation with key stakeholders. Key themes were how can we use international units to meet budgets and how the Commission can be politically neutral. Other events completed so far have included about six Dairy NZ workshops, a presentation at the Federated Farmers board meeting, a presentation at the Wellington Youth Council and at Field Days.

Coming up next: we continue to attend Dairy NZ workshops, host several youth events and university union events, host 10 more public meetings and ten more workshops as well as one online public meeting in collaboration with Stuff.co.nz.

Stuff and the New Zealand Herald covered the economic modelling announcement on Tuesday. Both items were balanced, however the Stuff article's headline did take an overly negative slant. We're anticipating more in-depth coverage in weekend media.

2.3. Discussion paper released on taking an integrated systems approach to land use change

The Policy Observatory at Auckland University of Technology has released a discussion paper titled 'The Interwoven World Te Ao i Whiria — Towards an integrated landscape approach in Aotearoa New Zealand'. The report, authored by Dr David Hall, argues that the current approach to rural land use isn't integrated enough, and that New Zealand is taking a 'siloed' approach. He argues this siloed approach will lead to suboptimal outcomes that are not prosperous over the long run, because short-term gains in profit and productivity are offset by mid- to long-term environmental harms that, in turn, create economic burdens.


As an alternative to this siloed view, Dr Hall advocates an integrated systems approach to land use, built on five principles of prosperity; climate alignment, sustainability, resilience, mauri ora and biodiversity. The report argues that these principles can best be brought together using a 'landscape approach', an emerging framework that integrates policy and practice for multiple land uses within a given area.

Dr Hall is critical of the One Billion Trees Programme. He notes that while providing grants for tree planting might mean that the target number of trees is reached, it is unlikely to be a durable solution because forest planting will retreat if grants are retracted, or if wider circumstances shift. Dr Hall sees the opportunity of the One Billion Trees Programme as less about meeting the target, but about creating the conditions by which this target can be met sustainably. He states that a systems change could deliver forest outcomes without needing to use, say, grants to swim against the tide of prevailing land use choices.

As there has also been a Radio New Zealand interview on this matter, there is a possibility that this will be picked up more widely as a concern with the One Billion Trees Programme. We will monitor any such feedback.

2.4. New emissions graph released shows agriculture emissions by livestock type

Last week the Ministry for the Environment released a new graph on social media showing the sources of New Zealand's gross greenhouse gas emissions. The graph is based on inventory data released in April, but also breaks down agriculture by livestock type using data obtained separately from the Ministry for Primary Industries' agriculture inventory model. The graph was released to generate interest for the Zero Carbon Bill consultation and has been shared over 350 times.



International

2.5. Ontario to end cap-and-trade following change of Government

The Ontario provincial election was held on 7 July. The Progressive Conservative party (the PCs), led by Doug Ford secured victory. The PCs campaigned on removing Ontario from the Western Climate Initiative cap and trade market (the joint ETS of California, Quebec and, since 2018, Ontario).

Post-election, Premier-designate Ford has stated that following the swearing-in of his government: they will end the trading system; serve notice to sever ETS links with California and Quebec; and that they have already directed officials to immediately take steps to withdraw the province from joint auctions. "As of June 29, the cap-and-trade, the carbon tax, they're done."

The Canadian Government has reacted strongly, warning Ontario that the current ETS complies with the federal requirement to have a sufficient carbon price and that if this is removed the federal government may impose its "backstop" tax. Ford also intends to challenge the Canadian federal government's legal basis for doing so. Ford has said he will direct his attorney general to prevent Ottawa from "arbitrarily imposing a carbon tax on Ontario families." While the smaller province of Saskatchewan is already challenging the federal carbon tax in court, the addition of Ontario, as Canada's largest province, would be significant.

2.6. International climate change meetings: Petersberg Dialogue and MoCA

Ministers and senior representatives from around 30 countries attended the 9th Petersberg Climate Dialogue in Berlin from 17-19 June. The theme for the meeting was "just transition", perhaps spurred by the challenges Germany is facing in meeting its targets, and the fact that, although renewable energy is growing, phasing out coal is proving difficult. Other themes included the Paris Agreement Work Programme, Talanoa Dialogue, and climate finance. The atmosphere was broadly positive, (a)

There were universal calls for the Paris Agreement Work Programme to be concluded with a balanced outcome across all issues, but there was debate about how much should be covered. On the Talanoa Dialogue, there were positive comments and calls for the political phase to focus most on 'How will we get there?'.

Common themes on just transition included the importance of inclusive dialogue; long-term planning; skills training and social support for affected sectors/regions; sharing experiences; mainstreaming climate policy; the public sector to drive change (as big component of all economies).

2.8 Funding to support Fiji's ongoing COP23 Presidency confirmed

New Zealand's further contribution of to support Fiji's ongoing COP23 Presidency has been confirmed this week via letter from Minister Peters to Fijian Prime Minister Banimarama. The legal arrangement confirming the additional contribution specifies that part of the funding will be used to acquire a pavilion space at COP24 which would be the venue for the sustainable agriculture event and other events on issues of priority to the Pacific.

At a signing event alongside New Zealand's High Commissioner, Fiji's Acting Prime Minister Aiyaz Sayed-Khaiyum welcomed the announcement noting "New Zealand has been a good partner for Fiji". The announcement of the funding has received widespread positive media coverage in Fiji.

2.9 Release of High Ambition Coalition's A Declaration for Ambition

New Zealand has now signed the High Ambition Coalition's *A Declaration for Ambition*, which commits signatories to explore ways to increase ambition following the Talanoa Dialogue (consistent with New Zealand's stated intentions), notes the importance of securing a robust set of Paris Agreement implementation guidelines at COP24, and communicates support for the United Nations Secretary General's efforts to galvanise political momentum.

The Republic of the Marshall Islands has already communicated its warm appreciation for New Zealand joining other signatories to the declaration: Fiji, Chile, Ethiopia, Finland, France, Germany, Mexico, Monaco, the Netherlands, Norway, Rwanda, Saint Lucia, Spain, Sweden, and the United Kingdom.

The Declaration was scheduled for release by the 23rd of June.
