Part 1: Current priority outcome areas

Valuing women's contribution

Pay Equity - Back Pay

Section 9 (2) (f) (iv)

Ministers have agreed that the draft pay equity legislation will reflect factors that must be taken into account in the exercise of discretion when considering back pay. Minister Lees-Galloway will recommend this approach to the Ministerial Oversight Group on State Sector Employment Relations when you meet on Thursday 5 July. We are advised that the Treasury will be responsible for a more detailed exercise on back-pay costings.

Reconvened Joint Working Group (RJWG) Principle 14

The Ministry was part of a RJWG meeting on Tuesday 3 July to discuss the best way to incorporate Principle 14 ("In establishing equal pay, other conditions of employment cannot be reduced") into the draft Equal Pay Amendment Bill. Representatives from the CTU, Business New Zealand, MBIE, and SSC were present, and agreed that the current wording of the Principle will remain unchanged.

Drafting Pay Equity Legislation

The Ministry has been invited to attend the drafting meetings for the Equal Pay Amendment Bill, led by MBIE. Drafting is proceeding, and Ministry and MBIE officials met with the CTU on Tuesday 3 July to discuss the CTU's comments on the draft legislation

Eliminating the Public Service Gender Pay Gap - Union Consultation

Following the agreement by Cabinet on the strategy for eliminating the public service gender pay gap, SSC and the Ministry will begin consulting with unions. We sought your approval last week of our consultation plan (*Joint Report: Eliminating the Public Service Gender Pay Gap – Plan for Consulting Unions 25 June 2018* refers). We have recommended the consultation achieves two outcomes. The first is feedback on the Strategy, so that you and Minister Hipkins can launch it publicly at the end of July. The second outcome is to agree how officials and unions will work together over the next two and a half years to implement the Strategy.

The main points of this consultation plan are:

- On Tuesday 3 July, the Ministry prepared a letter to inform the CTU and PSA of the Strategy, its
 alignment with the new Gender Pay Principles, and to formally initiate consultation. We understand
 this letter has been signed by Minister Hipkins and is ready for your signature.
- By Thursday 5 July, senior officials from the Ministry and the State Services Commission will send an email to unions requesting an initial meeting.
- Following agreement by Cabinet on the Strategy, we have prepared advice on the consultation
 phase with unions and the establishment of a taskforce to implement the Strategy.
