Dear Ms Baillie

Thank you for your email of 28 May 2013 requesting, under the Official Information Act 1982, the following information:

I wish to know how the ministry audits the taxpayers monies given to the Open Home Foundation annually. Understood in the year to 2012 to be \$29,605,024.46. Are the annual audits online, if not, may I please have a copy of them?

Organisations which provide services for Child, Youth and Family, such as the Open Home Foundation, must be approved under the Child, Youth and Family Standards for Approval. The Standards for Approval are based on legislation within section 396 and section 403 of the Children, Young Persons and Their Families Act 1989.

The complete Child, Youth and Family Standards of Approval are available online at <a href="https://www.cyf.govt.nz/documents/working-with-others/standards-of-approval.pdf">www.cyf.govt.nz/documents/working-with-others/standards-of-approval.pdf</a>.

The Open Home Foundation is approved as a Child and Family Support Service under section 396 and a Community Service provider under section 403 of the Children, Young Persons and Their Families Act 1989. For the financial year 2011/12, the Open Home Foundation received funding from the Ministry of \$9,206,147, and for the financial year 2012/13 a total of \$9,241,731. I have enclosed a table which breaks down those totals by contracted service.

The Standards for Approval ensure the Programme Quality Standards and Business Viability Standards are met. These are included so that organisations seeking formal approval status have robust policies and processes that ensure the safety of all children and young people using their services, as well as the continued viability of the organisation.

One of the Business Viability Standards relates to effective financial management. The annual audited accounts of each organisation are reviewed as part of an organisation maintaining its approval status.

With regards to your request for copies of Open Home Foundations audited accounts, Child, Youth and Family don't maintain copies of each organisation's audited accounts. Therefore I am unable to provide this information, under section 18(e) of the Official Information Act. You may contact the organisation directly to request copies of this documentation.
