Official Information Act requests relating to KiwiBuild Announcement at Papakura

Thank you for your Official Information Act 1982 (the Act) requests, received on 29 and 30 October 2018. You requested:

Request 01 – received on 29 October:

- "...1) All information held by your office relating to the KiwiBuild announcement reported here: https://www.odt.co.nz/news/national/ardern-welcomes-first-kiwibuild-families-new-homes.
- 2) All communications between you or your office with Derryn Jayne, Fletcher Ross and/or Dave Dobbyn since you were sworn in as prime minister...."

Request 02 – received on 30 October 2018:

"... please provide the total and itemised costs to the taxpayer of the "street party" referred to here:

https://www.nzherald.co.nz/nz/news/article.cfm?c_id=1&objectid=12149838.

This includes but is not limited to the cost of planning the event, catering and staffing, performance fees, equipment hire, and the cost of ministers and their staff travelling to and from the 'street party".

I believe that your second request of 30 October 2018 for information about total costs of the KiwiBuild announcement on 27 October 2018 is more closely connected to the functions of the Minister of Housing and Urban Development (Hon Phil Twyford). Accordingly, this request has been transferred under section 14(b)(ii) of the Act to Hon Phil Twyford, as the Minister of Housing and Urban Development.

The Minister of Housing and Urban Development has the usual time limits under the Act from receipt of this transfer to make a decision on this request.

We have interpreted your first request of 29 October to be for information held by this Office specifically about the event held on 27 October 2018 welcoming the first families into their KiwiBuild homes in Papakura. Please find enclosed documents held by this Office identified as being relevant to your request, as set out in the table below:

- Section 9(2)(g)(i) of the Act as withholding the information is necessary to "maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any department or organisation in the course of their duty".

Included as an attachment to the email in Document 9 in the table above was the media release "First KiwiBuild families welcomed to their new homes". This is available on the Beehive website at: www.beehive.govt.nz/release/first-kiwibuild-families-welcomed-their-new-homes. To the extent your request is for this document, it is declined under section 18(d) of the Act on the basis that the information requested is publicly available.

In addition, there were some documents identified as relevant to your request that have been withheld in full. These were:

- Included as an attachment to Document 7 above was personal details of the families who were purchasing the 18 KiwiBuild homes. This document has been withheld in full under section 9(2)(a) of the Act as set out above.
- An earlier draft of the run-sheet that was attached to Document 5 in the table above has been withheld under section 9(2)(g)(i) of the Act as set out above. The final copy the run-sheet has been released to you as an attachment to Document 9 in the table above.
- There was another attachment to Document 9 above that provided some advice to the Prime Minister for responding to questions raised by the media. This advice is withheld in full under section 9(2)(g)(i) of the Act as set out above.

Where information has been withheld, no public interest in releasing the withheld information has been identified that would be sufficient to override the reasons for withholding it.

You are entitled to ask the Ombudsman to review this response under section 28(3) of the Act. 


