Mr Sroubek appeared at callover this morning in relation to charges of [1] possession of class C controlled drug for supply (x 1) and conspiracy to supply a controlled drug (x 1). His appearance in this Court follows his conviction on 25 February 2016 in the District Court at Auckland. Hc was convicted of importing MDMA. He is awaiting sentence.

The Crown has advised that it is no longer in the public interest to proceed [2] with this re-trial and thus invites the Court to discharge the defendant under s 347 of the Crimes Act 1961.

In all the circumstances I am satisfied it is proper the defendant is discharged [3] in relation to the charges he faces in this Court and accordingly I make orders to that effect.

Mr Jones QC, for the defendant, requested that the present suppression orders [4] continue on the grounds that these are necessary for the defendant's protection. Mr Johnstone, for the Crown, opposed this course observing that there were suppression orders in the District Court and similar orders in this Court were unnecessary.

Given the paucity of information presently before me and the need to deal [5] with this matter in a way which is fair to all parties I directed Mr Jones to file and serve submissions in support of continued name suppression by midday on Friday, 11 March 2016 and for the Crown to file and serve its submissions in response by midday on Monday, 14 March 2016. The question of continued name suppression ar fu. will then be dealt with on the papers unless it is necessary to hear further from counsel.
