This letter is to provide you with an update about the Lakes DHB tobacco control services. Unfortunately I was unable to get hold of you today to provide you with a heads up in person that Lakes DHB is ceasing its smokefree coordination and smokefree midwife roles on 30 June 2018. As you know these roles are held by Yvonne Rogers and Tina Lees, both of whom will finish in their DHB roles on 30 June 2018.

This will affect many parts of the smokefree hospital and community work. At this stage the list below covers some of the work currently carried out by Yvonne and Tina, which will or will have the potential to affect the Tipu Ora Smoking Service work. I am also providing you with this information in case you may have enquiries around the DHB services and whether there is any potential for you to support and help with the ending of these services.

Specifically Lakes DHB will no longer provide the following:

- smokefree coordination
- smokefree resources
- bulk NRT supplies
- referrals from Yvonne and Tina to the smoking cessation service
- specialist smokefree cessation services
- chairmanship of the Lakes DHB Auahi Kore coalition meetings
- involvement in the smokefree retailers group
- resource to respond to smokefree enquiries by a dedicated team
- participate in the public smokefree spaces and policy development
- provide cessation support for Lakes DHB staff
- coordinate the provision of World Smokefree Day resources and
- Lakes DHB will not be accredited to provide smokefree training without Yvonne and Tina

Hopefully you can help and support us through this period. Also please contact me for more information.

Thanks for touching base. I am not sure what discussions have taken place with Pip to transition to a new space for cessation provision to be from the regional service. I have discussed the possibility with all concerned that we are open to your staff coming on site to provide cessation if you wanted to do that. It does happen in other hospitals in NZ. If you are not wanting to do that then happy for referrals to come your way via whatever you and Pip agree makes best sense. What will be needed is visability on responsiveness in the short to medium term to maintain confidence of hospital referrers esp if you decide to have no presence on the site. I have also talked to Tony who is not opposed to Tipu Ora providing cessation support to patients in hospital esp as then there is no handover and just a start of a journey with Tipu Ora (or continuation if you are already working with whanau who are admitted).

I am really sorry I am off site and fulltime committed to the strike action so will have to leave this discussion to you and Pip to resolve in a way that makes sense for all concerned before the 1st of July – even if that is a shorter term solution to allow more time to talk. I am pretty much out of action until , ACX 700after the 16th of July.

I have become aware of the changes happening at Lakes in the Tobacco Control area following communication from Pip King last week. I have indicated to Pip we would assist in areas we are able to that fall within our current Service Agreement for the Regional Stop smoking service. I am currently working through this and don't see any significant changes. The main area will be for Tipu Ora to "test" the current referral pathway ensuring we respond in a timely manner to any referral from both Rotorua and Taupo Hospitals to the Stop Smoking Service.

It has come as a surprise to receive an email from Dr Natalie Walker, Rauora Trail advising that Tipu Ora will now be delivering services inside the hospital – see commentary in email below.

I would like to meet or talk with you on the current situation so both parties move through the next phase without significant disruption or impact. – maybe if you could call me for a discussion would be helpful at this point. I am also keeping Tony Brown informed of these issues that arise and potentially fall outside of our contract agreement service delivery requirements. 10/h/6/


