## Official Information Act 1982 request

Thank you for your Official Information Act 1982 (OIA) request of 2 February 2019 requesting:

The names of Lawyers for Child who have received Lawyer for Child assignments from the Gisborne Family Court registry between 1 January 2018 to 31 December 2018; and the number of assignments received by each individual Lawyer for Child during that period from the Gisborne registry.

In response to your request, please see table 1 attached. This provides the names of Lawyers for Child and the number of Lawyer for Child service provisions assigned for files in the Gisborne Family Court, during the 2018 calendar year. Please note, a service provision is the way the Ministry of Justice records appointments of a third-party service provider, which in this context, is a Lawyer for Child.

In the extension letter of 4 March 2019, I included a table providing the number of approved Lawyers for Child in the Gisborne region. This differs from table 1, attached, in that table 1 also includes Lawyers for Child who are approved from other regions but have acted as a Lawyer for Child on Gisborne cases.
