Official Information Act request relating to all written communication from Richie Hardcore and members of the public concerning Karel Sroubeck

Thank you for your Official Information Act 1982 (the Act) request, received on 4 February 2019. You requested:

"...My OIA request refers to a previous OIA request from Mr. M Hooton https://fyi.org.nz/request/9243-texts-from-richie-hardcore-others-re-karel-sroubek I request all other forms of written communication, including but not limited to Facebook Messages and WhatsApp messages,

- 1) you have received from Richie Hardcore on any topic
- 2) you have received from any other private citizen concerning Karel Sroubek..."

In relation to the first part of your request, the Prime Minister, Rt Hon Jacinda Ardern, in her capacity as Prime Minister, has not received any further written communication from Richie Hardcore since the last message released to Mr Hooton in his request of 12 December 2018. Therefore, on this basis, I am refusing your request for any additional information under section 18(e) of the Act, as the information requested does not exist.

Regarding the second part of your request, please find attached correspondence that the Prime Minister received from other members of the public concerning Karel Sroubeck. This correspondence was received by the Prime Minister through email, her official Facebook account and by text message. Some information within this correspondence has been withheld under section 9(2)(a) of the Act, to protect the privacy of natural persons.

Further correspondence identified within the scope of your request includes, an email which was sent by Mr Sroubek's mother to the Director of the private, Serco-run prison as summarised in the below Stuff article. This email was forwarded to the Prime Minister on 5 January 2019. We can summarise that the letter from Mr Sroubek's mother related to her concern for the treatment of her son Karel Sroubek in prison. There is also correspondence from Mr Sroubek's father, which was received on 29 January 2019. I have decided to withhold the content of these emails under section 9(2)(a) of the Act as it relates to the privacy of natural persons, and due to the personal nature of the information contained in the correspondence.

I was a prisoner at ASCF where I served 12 months in the same six-person residence as Karel Sroubek aka Jan Antolik.

For the past couple of days I have vacillated about contacting you. It is much easier not to do anything and rely on the cards to fall where they will. BUT, I don't want prison to have dumbed me down and stolen all my humanity. I don't want to be a prisoner advocate but Jan's case is turning into an irrational bigoted clamouring for blood surely we are better than this.

In my position I got to read many prisoners sentencing notes as I helped them in preparation for their parole hearings. It was in this capacity that I got to read Jan's file plus the 2011 ruling from Judge Roy Wade who discharged him without conviction. At the time this Judge was clearly satisfied of concerns about Jan's safety if he were to be deported.

I don't need to relitigate evidence that you obviously have in front of you.

But, as much as a former prisoner can comment on character, I can't let some of what is being said slide. As a society we need to be judged by the height of our troughs rather than the height of our peaks and in prison we see how low our troughs are. Outside the wire there is a sad righteousness that is very unattractive. The National Party are milking a cheap stunt and in doing so revealing their miserable underside and transposing it on our society they should be assumed.

I think it would be a sad day that we stooped to this level and bowed down to this sort of mean spirited populism.

In terms of character today, I would say that Jan is a changed man. Under normal circumstances he would be a poster boy for prison reform. He busies himself with endless courses (all voluntary as his low security classification means he is inengable for any courses run by Corrections). Many were beneficiary of his skill as an instructor in the gym and he currently works at the Placemakers workshop within the prison walls. He has also become a very active leader of the yoga group within ASCF. Over and above the regular classes he did his own yoga reflection in our residence on a daily basis. It is now entrenched as an everyday part of his life.

I don't think any of us want to be judged too harshly on our past and would prefer to be judged by how we are as a person today. Jan has led a less than perfect life and admits this but it isn't so bad that New Zealand should place his life at risk. Everything I saw convinces me that he will be a positive contributor to our community upon his release... if we have the courage.

This is a situation that tests our compassion as a country so I am asking you to maintain your original position not to deport Karel.

I am not sure what I can add but am happy to receive any call to elaborate if this would assist.

Please continue to give your colleague Mr Lees-Galloway full support. As a member of the public I do not have the full details but I trust Mr Lees-Galloway made his decision fairly on the evidence provided. Since it was likely to be unpopular it shows he puts moral issues ahead of political advantage and that is the kind of MP we need.

Granting Karel Sroubek residency raises some issues:

1. The competancy of INZ or more specifically its under-funding. It is sad that Mr Lees-Galloway is being criticised because of failures of his predecessor.

2. Have you considered the issue from the point of view of the Czech govt? How would you respond if a Kiwi requested residency in a foreign country on the grounds that he was not safe to live in New Zealand?

Please assist MBIE by granting them the funding needed to review applicants for immigration. There is no need to reply to this email; I'd rather you spent the time thinking about our immigration policies and the ease with which they are abused.



It is becoming increasingly difficult to have confidence in decisions being made by your Government.

For one of the latest I refer to the current case of Karel Sroutek or Jan Antolik or what ever his real name is.

I, like most New Zealanders, was gob-smacked to hear the reports over the weekend that a convicted drug smuggler who gained entry to New Zealand on a false passport had been granted New Zealand residency by Immigration Minister Iain Lees-Galloway while serving a prison sentence.

Here's the Parole Board decision on Karel Sroubek or Jan Antolik. Extracts:

- evident however on his own admissions to the Board at the hearing before us that he was at that time associating with criminal elements in the Czech Republic
- has continued to do so is evident from his index offending which involved him being in contact with somebody that he had known in the Czech Republic (and we bear in mind that he left that country some 11 years ago now) who he says persuaded him to become involved in importing ecstasy through his importing business.
- admits to having associated with members of the Hells Angels gang
- his responses were self-exculpatory, evasive, long winded and ultimately in our view in many respects manifestly untruthful

Basically he was a criminal in the Czech Republic, he carried on being a criminal here, working with his criminal mates back home. He is associated with the Hells Angels and is a liar.

The PM says she backs her Minister's decision to grant him permanent residency in NZ. She also won't say why but at best we can guess they believe his story that he would be at risk from police officers if sent back to the Czech Republic.

Considering the Parole Board has concluded he is a liar, have they considered that his entire story is a lie? That he left the Czech Republic to avoid prosecution there?

"This was a very difficult decision, and it doesn't happen often." Ms Ardern told Breakfast host Jack Tame of the case, in which MP Iain Lees-Galloway used his power of absolute discretion. "It does point to the fact this is a tough job having discretion in cases like this."

Mr Lees-Galloway was forced yesterday to release a letter outlining strict conditions set for Karel Sroubek to stay in New Zealand. Mr Sroubek, who previously came to New Zealand under the alias Jan Antolik, is serving a five years and nine months prison sentence for importing about \$375,000 worth of ecstasy into New Zealand.

"I've given him one final chance to remain in New Zealand and live within our laws," Mr Lees-Galloway said.

Mr Lees-Galloway declined to cite his specific reasoning for the decision and Ms Ardern followed suit today.

"It's pretty obvious that on the face of it someone with this kind of offending to their name would usually be a quite straight forward deportation," she said. "And so there's obviously information that the minister has had to consider which has made this a tough decision for him...

"There's other information, obviously, the minister had in front of him that skewed his decision."

Generally speaking, there are some cases in which authorities have to factor in New Zealand's expectations under international convention, she said, pointing out that Sroubek was a resident of New Zealand prior to his conviction.

"This is an individual who already had residency, albeit under a false name, which is something that does happen from time to time when an individual claims that they are at risk if they use their original identity," she said.

The conditions set for Sroubek, 37, include not being convicted of another offence, assuming another fraudulent identity or concealing information from government agencies. The conditions will begin after his release from prison Out of Scope and last for five years.

When the law caught up with him, he admitted his criminal ties in the Czech Republic - but he seemed unable to escape old habits with several brushes with NZ Police over the past 15 years.

Sroubek has faced several charges, relating to drugs and robbery. But was either acquitted or had his convictions overturned - until he was found guilty of using his drink importation business as a front to smuggle 5kg of MDMA, which is used to make the drug Ecstasy. He was jailed for five years and nine months.

He was refused parole last month: Parole Board panel convenor Judge Phil Gittos said he gave "evasive, longwinded and ... in many respects manifestly untruthful" responses.

So, Labour has allowed residency for a violent, gang associate, drug dealer. They really are taking crim-hugging to whole new depths with this one.

- s9(2)(a) I can understand and appreciate the dilemma and subsequent quandary that Minister Lees-Galloway has found himself.

Attached is a timeline for your consideration.

Black type: a believed factual statement on an event / situation re Antolik / Sroubek

Blue type: my observations / comments

Red type: questions that I believe need to be asked

You have confirmed that Immigration New Zealand has been directed by Minister Lees-Galloway as its highest priority to investigate this matter and report back within three weeks. I agree that it is imperative for the credibility of the Government, the credibility of our immigration process, that there is an investigation. However, I believe it is inappropriate for INZ to conduct this investigation because:

- 1. INZ have admitted that they did not provide all relevant information to Minister Lees-Galloway
- 2. Michael Woodhouse blames INZ for the inaction over Antolik / Sroubek by himself and his predecessors (Jonathan Coleman and Nathan Guy)
- 3. Deputy Prime Minister Peters is also reported as indicating his belief that INZ is largely to blame for the Antolik / Sroubek debacle (something I agree with)
- 4. The actions and judgements of various judges needs to be assessed / analysed, and it is inappropriate for INZ to do this.
- 5. It is a massive conflict of interest for INZ, given it appears the party that has had the primary involvement in "screwing up" this situation is INZ

I remain puzzled at how Minister Lees-Galloway managed to convince himself that granting (confirming) residence for Sroubek was the appropriate action. However, I am also well aware, \$9(2)(a) that the Minister's decision is often only as good as the advice he has received.

I am also of the opinion that Minister lees-Galloway should not resign or be dismissed as Minister of Immigration – and at least not until a full independent report has been considered.

I do not, and have not, agreed with all immigration decisions made by Minister Lees-Galloway and/or Minister Faafoi. However, in my opinion (and I believe by the great majority of \$9(2)(a)), those ministers inherited an INZ that was dysfunctional and riddled with incompetence.

INZ has always been a target for dissatisfaction, disappointment frustration, and given the responsibilities they have, always will be. However, it is a situation that has deteriorated massively over the period of the 9 years of the National led government.






