


Amendment to Contract Documents

These amendments are entered into between the parties identified on the attached program signature form. They amend the Enrollment or Agreement identified above. All terms used but not defined in these amendments will have the same meanings provided in that Enrollment or Agreement.

For the purposes of this Amendment, "Entity" can mean the signing entity, Customer, Enrolled Affiliate, Government Partner, Entity, or other party entering into a volume licensing program agreement.

Enrollment for Education Solutions Early Commitment Amendment ID CTM

The parties agree that the Enrollment is amended by adding a section entitled "Early Commitment."

Early Commitment

- a. In this Amendment, "Entity" can mean the signing entity, Customer, Enrolled Affiliate, Government Partner, Entity, or other party entering into a volume licensing program agreement.
- **b.** Entity agrees to sign and complete the documents listed in the Program Signature Form prior to 30 June 2018. With the exception of the document listed in the appendix section which must completed, signed and submitted to Microsoft by 15 December 2018.
- **c.** Microsoft will process the agreement by 30 June 2018 but Entity's Reseller shall only be invoiced one day following the Expiring Enrollment.
- **d.** The effective date of this Enrollment shall be one day following the Expiring Enrollment #7028880.
- e. Entity's initial order under this Enrollment, must be submitted prior to 15 December 2018 and must include a subscription of Microsoft 365 A3 for the Organization wide count ordered under the Expiring Enrollment number #7028880 for 36 full calendar months from the day after expiration. The following conditions apply to this renewal:







New Zealand Law

The parties agree that Sections 14(g) and 14(h) of the Campus and Schools Agreement will be replaced in its entirety with the following:

The terms of the agreement and each Enrollment entered into will be governed by the laws of New Zealand, and Microsoft and Entity will bring any action to enforce that Agreement in New Zealand. This choice of jurisdiction does not prevent either party from seeking injunctive relief with respect to a violation of intellectual property rights or confidentiality obligations in any appropriate jurisdiction. The 1980 United Nations Convention on Contracts for the Sale of Goods and its related instruments will not apply to this agreement.

If there is any conflict between any provision in these amendments and any provision in the Enrollment or Agreement identified above, these amendments shall control.


Enrollment for Education Solutions Consortia Amendment Amendment ID CTM-EES23

The parties agree to amend the Enrollment as follows:

1. The following new section entitled "Additional Terms" is hereby added.

Additional Terms

- a. Sublicensing. Entity may sublicense its Licenses to Products acquired under its Enrollment to Participants as specified in this section.
 - (i) Participants. A "Participant" means an educational Entity that (1) meets the Microsoft definition of Qualified Educational User located at <u>www.microsoft.com/contracts</u>; (2) is a member of Entity and is identified by Entity on the Participant Form attached to this amendment, and (3) has duly executed a Participation Agreement.
 - (ii) Participation Agreements. Prior to sublicensing any Licenses to a Participant, Entity will verify that it has received an original, executed Participation Agreement from such Participant. Entity will maintain all original, executed Participation Agreements on its premises during the term of the Enrollment and for one year thereafter. During this time Entity shall make copies of the Participation Agreements available for inspection by Microsoft at Microsoft's request. Entity assumes joint and several liability to Microsoft for any acts or omissions of any Participants which, if taken or omitted by Entity as a licensee, would amount to a breach of the Enrollment.
 - (iii) Communication. Entity agrees to establish and maintain a website and email distribution alias for the purpose of communicating pertinent information to Participants. Entity agrees that the website will be active within fifteen (15) days after this amendment becomes effective, and that it will be reasonably maintained. Entity further agrees that the email alias will be active within thirty (30) days after this amendment becomes effective.
 - (iv) Enrollment. The section of the Enrollment entitled "Defining Entity's Organization" is hereby replaced with a Participant Form attached to this amendment. The Enrollment will not have an Enrollment number; each Participant will be assigned an individual Participant Enrollment number instead.
- b. Entity does not need to meet the Microsoft definition of Qualified Educational User located at <u>http://www.microsoft.com/contracts</u> so long as Entity does not order Products for use by non-Participants (including Entity's own Organization's internal use).

















Except for changes made by these amendments, the Enrollment or Agreement identified above remains unchanged and in full force and effect. If there is any conflict between any provision in these amendments and any provision in the Enrollment or Agreement identified above, these amendments shall control.
