I have opened a police investigation now as the extent of their cyber bullying against me is progressively getting worst, but I don't know if anything will get done about it. I also believe the lady who was in the original stuff article is a part of this, as new evidence from my contact at media-works has come forward.

If you were able to find out who was behind my cyber bullying attacks, would you be interested in helping me to unveil who is behind it?

I am not sure if you are allowed to do this kind of story legally,

Essentially I just want them to stop, but so far, the Police and Netsafe have not been helpful, despite my belief that this is a breach of the Harmful Digital Communications Act. I feel like no body cares and nobody wants to help, so I am wondering if having the media unveil who is doing it will get them to stop?

For 2-3 months, the cyber bully has been:

- Sending emails with false information and false allegations about me to several different media outlets (mediaworks I have the email, 1 News), in order to get them to publish negative articles with false information about me, the email sent to mediaworks contains is happy to speak out about this, as her and her daughters friends are very involved"
- Sending emails with detrimental false allegations about me to my business partner Briar to get Briar to stop working with me
- Sending emails with false allegations about me to my Sponsors AMI Business Insurance to try to get them to stop working with me.
- Impersonating me by creating false social media accounts to bully members of the public, and then saying it was me on their fake facebook page created to make fun of me: https://www.facebook.com/CelebrationBoxNZ/ as well as sending it into news outlets such as 1 news (the screenshot you received from was of daughters instagram account)

And more...

If is indeed a part of this, I do not know why an adult woman is spending so much time on this. She was one of our customers for my business Celebration Box, her order wasn't received on the Friday she ordered it for due to delivery problem, and she was refunded the following Monday. For that to stem into 2-3 months of cyber bullying me is really frustrating.
