I refer to your official information request dated 25 February 2019 for the following information:

- 1) The content of all documents and emails noting National Security concerns, resulting in blocking Spark from using 5G equipment from Huawei;
- 2) All communications between the GCSB and Spark regarding "significant national security risks" with Huawei 5G;
- 3) All communications between the GCSB and Ministers regarding national security concerns with Huawei 5G, including the Minister responsible for the GCSB.
