
Michael,

DIA is consulting agencies consulted prior to the Bill's introduction, seeking comments (including nil comments) because the Government Administration Committee (that considered the petition) principal recommendation would require a change to the existing law (sections 28–29 of the Births, Deaths, Marriages, and Relationships Registration Act 1995; clauses 66–70 of the Bill).

Background

Petition 2014/86 of Allyson Hamblett called on the Minister of Internal Affairs to enable adults with intersex conditions and trans and other gender diverse adults to change the sex details on any official documentation to male, female or indeterminate based solely on the individual's self-identification, without any requirement for medical treatment and without the need to resort to a court process."

Section 28 of the Births, Deaths, Marriages, and Relationships Registration Act 1995 enables an eligible adult to apply to the Family Court for a declaration to change the sex that appears on their birth certificate. The Family Court considers applications on a case-by-case basis. The Family Court follows the approach adopted in *Re Michael*. That is, there is no minimum threshold for medical treatment, and no requirement for an applicant to undergo some (or any) surgery before seeking a declaration.

Advice provided to the Committee by DIA (which is consistent with Ministry of Justice advice) is that provisions in the Act are consistent with the Bill of Rights Act 1990. The Ministry of Justice consider the Family Court is best placed to consider the evidence tendered in support of an application, as well as interpreting the requirements of the process in a rights-consistent manner.

The Committee presented its report (on the petition) to the House the day after the Births, Deaths, Marriages, and Relationships Registration Bill was introduced. The Bill had its first reading completed 5 December 2017, and has been referred to the Governance and Administration Committee.

The Committee supported Ms Hamblett's call (as does the Human Rights Commission) for a change to the 1995 Act to enable an individual to change the sex on their birth certificate through an administrative process based on self-determination. The Committee also supported Ms Hamblett's call for an equivalent process in the Citizenship Act 1977 so a citizen by grant (mostly those born overseas) can obtain a new citizenship certificate with amended personal details.

The draft Cabinet paper notes that the upcoming select committee hearings and submissions on the Bill provide a timely opportunity to fully test the impact of the current law (carried over in the Bill) on transgender individuals.

Privacy Considerations and next steps

The petition seeks to modify the procedure about updating the sex details on official documentation. The proposed changes would involve amending the mechanism by which changes can be made. The proposals to not raise particular privacy issues, they are more directly founded on issues of human rights.

Submissions on the Births, Deaths, Marriages, and Relationships Registration Bill are now being accepted with a closing date of 02 Mar 2018. It is our intention to submit on this Bill.

Recommendation

I recommend that we thank DIA for consulting with us and advise that we have no comment at this stage but signal that we will be submitting on the Bill in due course.


